OVERVIEW OF THE ADMINISTRATION AND REGISTRATION TOOLS SYSTEM

The Administration and Registration Tools (ART) system allows authorized users to create and manage records, users, and entities such as states, districts, and institutions. You can upload records in groups or manage them individually in ART.

Inter-relation between the Administration and Registration Tools System and other Smarter Balanced Systems

ART has connections to the following Smarter Balanced systems.

- **Single Sign-On (SSO):** This system is responsible for user authentication and authorization, and allows you to log in to the Smarter Balanced systems. After logging in, you can switch between systems without logging in and out of each system. Users added through ART are automatically added to SSO, and permissioned users added to SSO can log in to ART.
- **Reporting Data Warehouse:** This system stores student groups and results for assessments.

User Roles and Permissions

ART restricts access to certain tasks based on your designated role. You can access the data stored in ART and perform tasks based on your permissions. [Table 1](#) lists the standard roles in ART.

Table 1. Standard ART User Roles

User Role	Description
State Coordinator	State Coordinators can create other State Coordinator accounts as well as District Coordinator, School Coordinator, and Test Administrator accounts. They can upload data across all districts and institutions within their states.
District Coordinator	District Coordinators can create other District Coordinator accounts as well as School Coordinator and Test Administrator accounts. They can upload data across all institutions within their districts.
School Coordinator	School Coordinators can create other School Coordinator and Test Administrator accounts. They can upload data for their institution only.

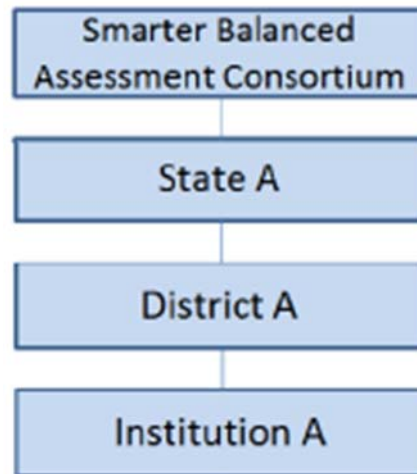
Understanding the Smarter Balanced Hierarchy

The Smarter Balanced hierarchy organizes entities. For this user guide, the term “entity” refers to institutions, groups of institutions, districts, groups of districts, and states. [Figure 1](#) provides a simple hierarchy, please note that it is not representative of the entire available structure. In this case, a teacher is associated with an institution, the institution is in a group of institutions, the group of institutions is in a district, the district is in a group of districts, the group of districts is in a state, and the state is a member of the Smarter Balanced consortium. You may construct hierarchies with different structures as well.



You can rename any of these entity levels. For example, you may choose to rename “Institution” and “Group of Institutions” as “School” and “Group of Schools,” respectively.

Figure 1. Simple Smarter Balanced Hierarchy



- All relationships are limited by permissions. For example, a user at the institution level cannot add users or entities to the district level, but a user at the district level can add users to institutions within that district.
- An entity or user must have only one “parent.” The parent is the entity to which another entity or user belongs. For example, an institution can be in only one district, and a district can be in only one state.

About Microsoft Excel Files

The Administration and Registration Tools system allows you to upload files in one of two formats: .csv and .xlsx. Your version of Excel impacts the file format you should select or use.

CSV (comma-separated values):

If you have Excel 2003 or earlier, Smarter Balanced recommends that you download exported records in .csv format. CSV files do not automatically preserve leading zeros (numbers that begin with at least one zero at the beginning, e.g., 0001234).

Excel:

Microsoft Excel 2007 and later .xlsx files automatically preserve leading zeros. These files cannot be opened using an earlier version of Excel.

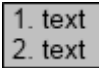



This user guide provides information about using ART to create and manage assessment registrations and schedules. This introduction describes the contents of this document and includes a key for identifying icons and elements.

ACCESSING AND UNDERSTANDING THE ART INTERFACE

This section contains information about how to log on to ART, how to reset a forgotten password, and navigate the ART user interface.

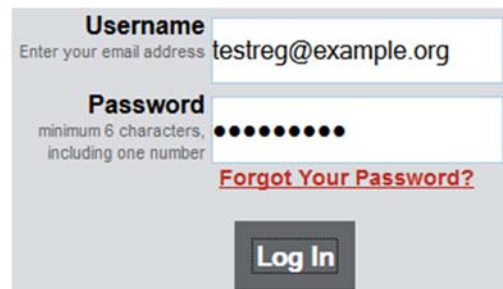
Logging on to ART

To access the Administration and Registration Tools System, you must have an authorized username and password. Since the Administration and Registration Tools System is an open-source system, your system administrator will be responsible for setting up your user account and providing you the login credentials.

To log in to the Administration and Registration Tools System:

1. Open your web browser and navigate to the Administration and Registration Tools System using the URL provided to you. You will be directed to the Single Sign-On Login screen.
2. In the *Username* field, enter your username.
3. In the *Password* field, enter your password.
4. Click [**Log In**]. You will be directed to the Administration and Registration Tools System home screen, provided your login is authenticated.

Figure 2. Login Screen

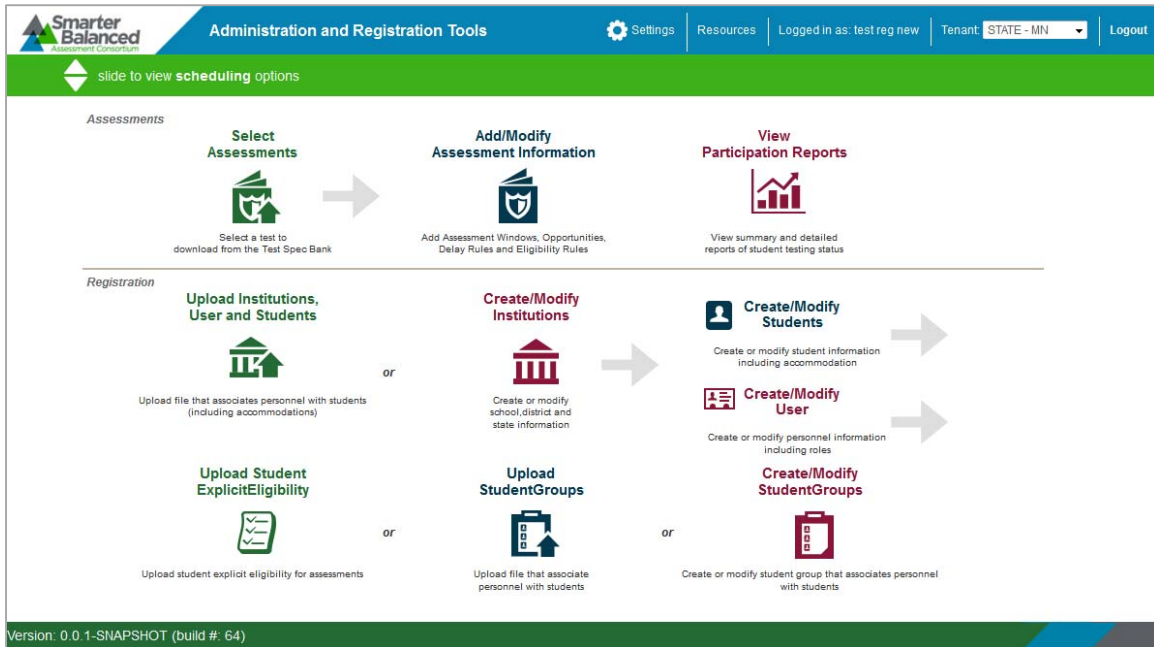

ART Home Screen

The first screen you see after logging in to ART is the ART home screen. You can click the button for a task to begin working on that task. The tasks that are available on the home screen depending on your user role. [Figure 3](#) displays the home screen for the Client Coordinator role.

Do not have more than one ART browser tab or window open simultaneously. Changes made in one tab or window may overwrite changes made in another, resulting in loss of data.

The ART home screen provides brief directions for the required workflow. The arrow (→) symbols indicate precedence: you must complete a task to the left of the symbol before performing the task to the right. The “or” indicates a choice between one of the tasks. For instance, you must upload institutions before you can create users, etc.



For the Smarter Reporting System, ART’s primary use is for uploading institutions and creating users. Student Groups, for example, are managed elsewhere. Many of the tools on the home screen will not be used by Service Providers.

ART Banner

The ART banner at the top of the screen displays the following information and links:

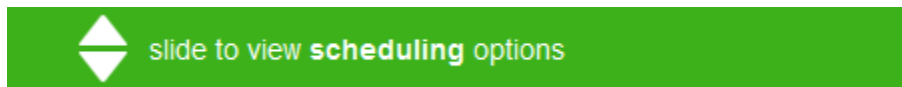
- **[Smart Balanced]** logo—Click to return to the home screen at any time.
- **[Settings]**—Click to configure system-wide settings.

- [Resources] –Click to access the *Download Templates* screen or view the user guide.
- [Your user name] – Click to **Edit Profile** or **Logout**
- [Tenant] –Your tenancy, the state or client associated with your logon.
- [Logout]–Click to log out of the site.

Task Bar.

The task bar below the banner enables you to switch between registration tasks and assessment administration tasks, such as scheduling. By default, the home screen displays the registration tasks. To view the assessment administration tasks, click the arrows shown in Figure 4.

Edit Profile

Users can edit/modify their profile, including:

- Change/reset password
- Change email address
- Change First and Last Name
- Change phone number
- Delete assigned roles (cannot add a role)

To edit your profile:

1. On the ART banner, at the top of the screen, select your user name
2. Select *Edit Profile*
3. Modify your information
4. Click **[Save]**



When changing/resetting your password, you do not have to log out of your current session. You will be required to enter your new password the next time you log in.

User Actions

CREATING RECORDS IN ART

This section describes how to build a hierarchy of entity records from the state level to the institution level. You can upload entity and user records in groups, or create each record individually with the ART user interface. You can create or modify records using the following methods:

- **File Uploads:** This feature allows you to upload many records using predefined templates, which can be constructed in Excel. Depending on your user role, you can upload state, group of states, district, group of districts, institution, group of institutions, user, student, student group, student accommodation, and student eligibility records. In most cases, you can use file uploads to modify or delete existing records.
- **Create/Modify Records:** This feature allows you to create individual records using the forms provided on the ART user interface. Depending on your user role, you can create state, group of states, district, group of districts, institution, group of institutions, user, student, student group, and student accommodation records. You can also use the **Create/Modify** features to modify or delete existing records in ART.

File Uploads.

The process for uploading files to ART consists of three main steps:

1. Download the appropriate file template for the record type.
2. Fill out the template by entering the information for each record in a new row.
3. Save and upload the file to ART.

Download File Templates

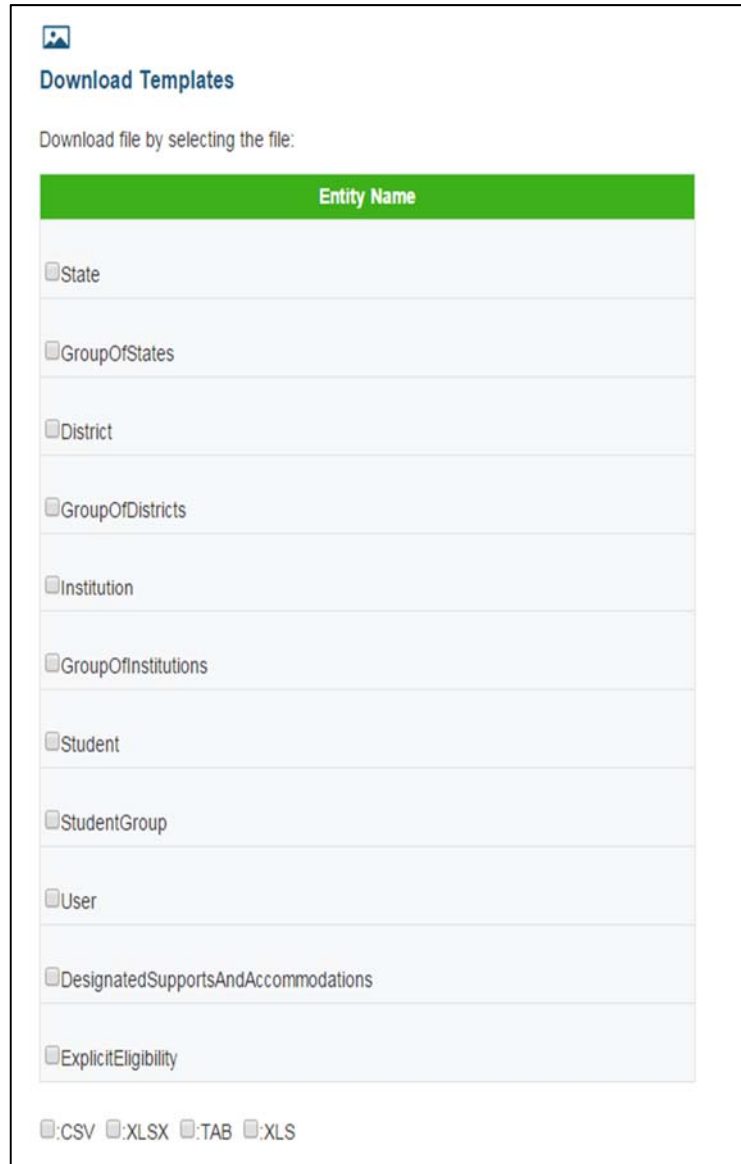
The best way to create upload files for the various types of records is to use one of the available file templates. These templates organize records into tables, and you enter data into the tables—one row for each record. Using the template reduces the risk of errors, and helps to ensure that your file upload is successful.

Templates are available in CSV, XLSX, TAB, and XLS formats.

To download file templates:

1. In the ART banner, select “Download Templates” from the Resources drop-down list. The **Download Template** screen opens.
2. Mark the checkboxes corresponding to the templates you want to download. For example, if you want to download templates for states or districts, mark the **State** or **District** checkbox.
3. Mark the checkboxes corresponding to the format you want to download. For example, if you want to download templates in the CSV format, mark the **CSV** checkbox. The [Download] button appears.
4. Click [Download]. Your browser downloads the files. Depending on your browser’s configuration, the files open in the appropriate application or are stored on your computer.

Creating an Upload File.

Each template consists of columns appropriate for the record type you selected. The top row in the template contains the data columns for which you enter the appropriate information. You enter the information for each record in the subsequent rows.

CAUTION: Validation Errors. Editing values in the top row of a template file results in validation errors when uploading the file. Do not edit values in the top row of a template file.

Multiple Entries in a Data Cell. For fields in which multiple entries are permitted each entry should be separated with a semicolon.

To create an upload file:

1. After downloading the appropriate template, open the file in Microsoft Excel or a compatible spreadsheet program.
2. Enter each record's information in a separate row. Be sure to adhere to the field requirements described in the appropriate table provided in the Managing Records section.

Note: Upload templates are case-sensitive. Data must be entered as standard text. Any formatting, such as boldface, highlighting, or italics, will be lost during the upload.

- To delete an existing record, enter "DELETE" in the Delete column for that record.
- To modify an existing record, enter the new information for that record. The old record will be replaced upon uploading the file. To modify the key value of a record (e.g., the email address of a user record), you must delete the original record and create a new one. The tables in the Managing Records section identify key columns with a plus (+).

*Note: Some record types cannot be deleted or modified via the file upload task. You must delete or modify those records from the **Create/Modify** screen for that record type.*

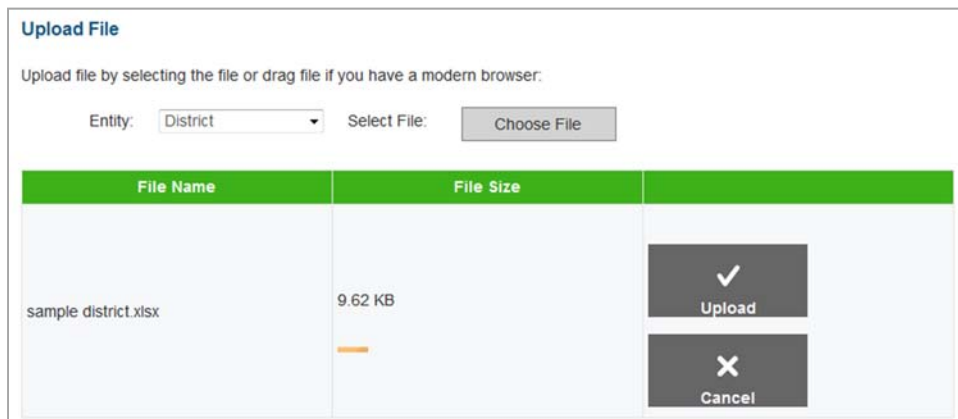
3. Save the upload file in one of the following file formats: CSV, XLS, XLSX, or TXT. After the file is saved, you can upload it to ART.

Uploading Files.

The file upload process has four main steps: (1) Choose File, (2) Preview File, (3) Validate File, and (4) Confirmation. This process allows you to confirm that the correct file was uploaded and that it contains no errors. When uploading a file, you must use the correct upload screen for that record type.

Step 1: Upload File

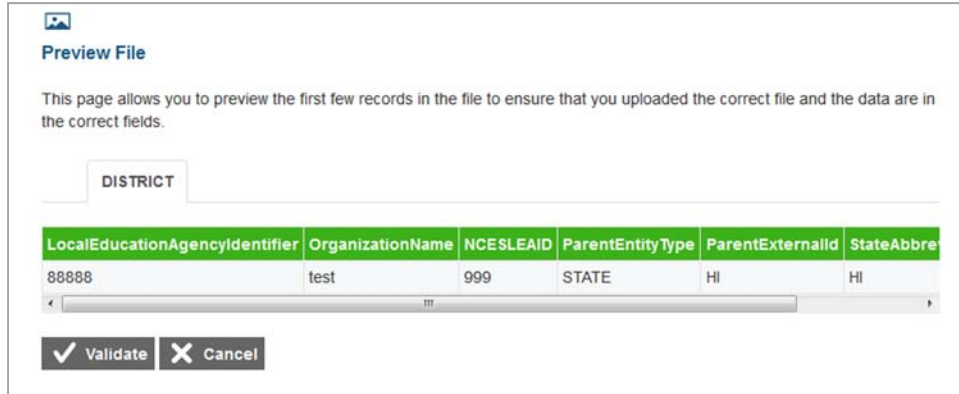

1. On the home screen, navigate to the appropriate file upload screen for the record type.
2. Select the record upload type from the *Entity* drop-down list on the **Upload File** screen.
3. Click [**Choose File**] and select the saved file on your computer. The file name and file size appears in the table on the screen. *Note: If you are using a modern browser, you may also click and drag the file directly into the table provided on the upload screen.*
4. Verify that the name of the file is correct, and then click [**Upload**].

1. To ensure that you uploaded the correct file, you can preview the file you selected in the table on this screen. *Note: Only the first few records in the file are visible on this preview screen.*
2. To begin the file validation process, click [Validate].



Caution: If your file is large, uploading it may take a long time. DO NOT cancel the upload and try again, because ART may have already begun processing some of the records. If your file is too large to upload while you are online, you can minimize the file by separating it into smaller files. Smaller file uploads can be processed simultaneously in separate browser tabs with one upload per tab.

Step 3: Validate File

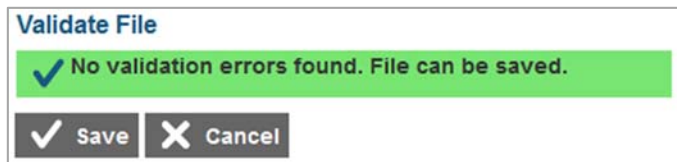
If the file passes validation, a message appears, indicating that no validation errors were found (see [Figure 10](#)). You can click [Save] to proceed to the final step.

If the file contains records with errors, an error message appears (see [Figure 11](#)). Depending on the severity of the error, either the entire file will fail or just the records with errors will fail.

Files with data that are not in the correct format as shown in the template will generate error messages by row, identifying the errors in the file.

The “Understanding Error Types” section in the column to the right provides a brief explanation of the three possible error types: fatal errors, record errors, and record warnings.

Understanding Error Types






-  **If the entire file fails**, note the errors and the corresponding record numbers. Click [Cancel], update your file, and then restart the upload process from Step 1: Choose File.
-  **If the file contains record errors**, these records *will not be committed* to ART. The records that passed validation can be committed. You may elect to fix the errors in your file and re-upload it, or to add these records individually on the appropriate **Create/Modify [Record]** screen.
-  **If the file contains record warnings**, these records will be saved to ART. However, you are strongly encouraged to review the associated records. You may edit these records using the appropriate **Create/Modify [Record]** screen.

If your file has errors

Files with data not in the correct format as shown in the template generate error messages by row, identifying the errors by line (row) for each invalid record in the file.

Some errors prevent a record from uploading (e.g., invalid parent entity). A table of validation messages appears and contains information about the errors. *Note: A single record can have multiple errors.*

- **Record #:** The row in the file in which the error appeared
- **Field Name:** The column name that contains the error
- **Field Value:** The text that you entered in the cell
- **Validation Message:** A brief description of the error


Depending on the severity of the error(s), one of the following will occur:

- The file will fail to upload.
- The file will upload, but ART will exclude the record(s) that had errors.
- The file will upload, and ART will accept the record(s) that had errors. (These records will need to be fixed in ART or uploaded in a new file.)

Figure 13. Failed Validation

 Error(s) of this type will cause the entire file upload to fail. Click Cancel, update your file and restart the upload process.

 File can be saved but records with this type of error will not be included. You may elect to fix the errors and re upload the file or add these records later using the administration option to manage this type of file records.

 These are warnings. File can be saved. However, you are strongly encouraged to review the associated records. You may edit these records using the administration option to manage this type of file records.

If your file included errors, you have two options:

- **Abort the upload.** Click [Cancel], and then click [OK]. You can then make edits to the upload file, save it, and begin the upload process again.
- **Proceed with the upload, and add the information to ART.** To do so, click [Save]. Only error-free records or records with acceptable errors (rows in yellow) will be uploaded to the system.

These are some common errors:

- Having blank rows between records or at the end of the file
- Inserting invalid characters (refer to appropriate user guide sections for information about accepted formats)
- Uploading a file that contains parent entities that do not already exist in ART.
- Uploading a file for users in an institution or district with which you are not associated.

Step 4: Confirmation

After you click [Save], the accepted records will be uploaded to ART. A table appears, confirming the type of records uploaded, the number of records deleted, and the number of records inserted.

Figure 14. Upload File, Step 4: Confirmation



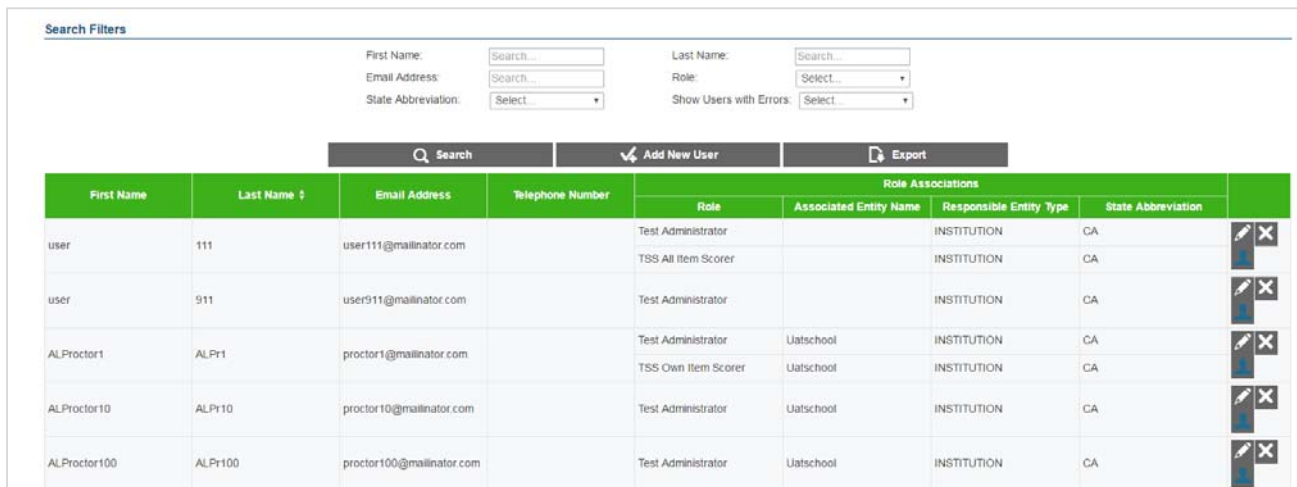
Creating/Modifying Individual Records.

The **Create/Modify** screens in ART allow you to add, modify, and delete individual records. You can also use these screens to search for and export records. When working with a record, you must use the appropriate screen for that record type. [Table 3](#) describes the available screens and the record types that they process.

Table 3. Record Management Screens

Screen	Description
Create/Modify Institutions	Use this screen to manage state, district, group of districts, institution, and group of institutions records. <i>Note: When managing entity records, you must select the appropriate entity type from the links provided at the top of the screen.</i>
Create/Modify Users	Use this screen to manage user records.

The following items are available on every **Create/Modify** screen:

- Filter fields and [**Search**] button used to search for records. Some **Create/Modify** screens also include a checkbox that filters the search results table to only display records with errors.
- [**New**] button used to create new records.
- Various [**Export**] buttons used to export data for all records or just records in the table.
- Search results table that displays existing records. By default, this table displays all existing records. The table includes action buttons used to edit or delete individual records.



The actual filter fields and table columns on the **Create/Modify** screens vary for each record type. For more information, see the Managing Records section.

To add a new record:

1. Click [**New**]. The **Add [Record Type] Information** screen appears. This screen displays fields for creating a new record.
2. Enter the record's information in the provided fields. Be sure to adhere to the field requirements described in the appropriate table provided in the Managing Records section.
3. Click [**Save**].


To search for records:

1. On the **Create/Modify** screen, enter values in the filter fields and click [**Search**]. The table updates to display only the records that meet the entered criteria.


To export records:

- To export all the records as an XLS file, click [**Export Search Results to Excel**].
- To export all the records as a CSV file, click [**Export Search Results to CSV**].
- To export only the filtered records included in the table as an XLS file, perform a search and click [**Export Current Page to Excel**].
- To export only the filtered records included in the table as a CSV file, perform a search and click [**Export Current Page to CSV**].

To modify an existing record:

1. In the search results table, click [] for a record. The **Edit [Record Type] Information** screen appears. This screen is similar to the screen used for adding new records.
2. You can modify the record's information in the available fields. Be sure to adhere to the field requirements described in the appropriate table provided in the Managing Records section.
3. Click [**Save**].

To delete a record:

1. In the search results table, click [] for a record. A warning message appears, asking you to verify the action.
2. In the warning dialog box, click [**OK**]. The record will be removed from ART. **Caution: This action cannot be undone.**



Caution: If you delete the record for a parent entity, then all the child entities that belong to that parent will also be removed from ART. For example, if you delete a district record from ART, then all the institutions that belong to that district are also deleted.

About Data Columns and Edit Fields.

For a given record type, the fields displayed on the **Add [Record] Information** and **Edit [Record] Information** screens correspond with the data columns included in the template used to upload that same record type. Column labels on the template use CamelCase, while fields on the **Add [Record Type] Information** and **Edit [Record] Information** screens use Title Case. Otherwise, these labels are usually identical.

For example, the **Add District Information** screen includes the *Organization Name* field. The corresponding column on the District template is "OrganizationName." See [Figure 16](#).



The "Delete" column in upload templates does not have a corresponding field on the **Add [Record] Information** and **Edit [Record] Information** screens, because individual records are deleted directly from the search results table on their **Create/Modify** screen.

MANAGING RECORDS

The following sections provide instructions for creating or modifying the various record types, as well as detailed information about creating, modifying, or deleting records through file uploads.

Managing State Groups.

When building the hierarchy of entities in ART, you must start at the state or state group level. A state group consists of multiple states that are associated together and belong to the same client.

Note: The actions described in this section are available to users with a client-level role.



All entity group levels in the Smarter Balanced Consortium hierarchy are optional. You can configure and rename these entity group levels.
