Data Exchange Protocol

Student Registration data are expected to be transferred using SFTP to a tenant specific landing zone. The chroot jail landing zone enforces files to be either added and or deleted in a specific directory. We expect the tenant to provide their public SSH key which will be saved in our landing zone server. This allows tenants to SFTP without the need of a password.

The CSV and JSON files are expected to be Tar, GZip, signed and encrypted into one file, known as the Landing Zone file. The expected extension of the file is .tar.gz.gpg.

Encryption

GnuPG 1.4 is used for encryption of data files and we recommend using AES256 as the encryption algorithm. Encryption key needs to be exchanged between us and the client. The process involves the client generating a set of keys used for signing and then sharing the public key with us. In return, we share the public key that is used for encryption with the client.

Example commands to create a Landing Zone file:

1. Tar GZip the CSV and JSON files

```
tar -cvzf studentRegData.tar.gz data.json meta.csv
```

2. Sign and Encrypt the file

```
